Special Meeting March 1, 2011

I. Call To Order

The workshop portion of the meeting held by the Bradley Beach Board of Education was called to order at 7:03 p.m. by President Charette at the school, 515 Brinley Avenue, Bradley Beach, NJ.

Executive Session

President Charette called for an Executive Session at 7:04 p.m. to discuss personnel matters.

Public Workshop Reconvened

On a motion made by Mr. Migdon, and seconded by Mr. Bardinas, the Board reconvened into the workshop session at 7:17 p.m.

Superintendent's Report

Dr. Turner began the workshop session by going over his agenda items. In particular Dr. Turner discussed the appointment of the new music teacher.

Special Meeting March 1, 2011

Mr. Tonzola then went over his agenda items with the Board. Mr. Tonzola went over the budget calendar with the Board and indicated that the building of the budget has been an ongoing project since early February. Mr. Tonzola stated that the general fund budget will be decreasing by .58% and that the tax levy will be increasing by \$77,717 or 1.60%. The new general fund tax levy of \$4,934,068 represents a general fund tax rate of .4335 cents per \$100 of assessed valuation. Furthermore, the proposed 11/12 general fund tax rate represents a .0039 cents increase from the current year's general fund tax rate of .4296 cents per \$100 of assessed valuation.

Mr. Tonzola also stressed to the Board that this is a tentative budget and that the district can still make changes up to the public hearing on March 29th. Mr. Tonzola also informed the Board that on March 11th there will be a meeting with the Executive County Superintendent and Executive County Business Administrator to discuss the tentative budget.

After going over the budget and tax levy with the Board, Mr. Tonzola went over the remaining agenda items.

On a unanimous voice vote the workshop portion of the meeting adjourned at 7:36 p.m.
