He was concerned that the new teachers, who were going to learn the program, would still need a mentor to teach them and guide them in the process of the Wilson Reading Program. Mr. Sacci also expressed his concern regarding students' proficiency in spelling on assignments and tests.

Beth Kepler, 504 Central Avenue, first congratulated all the incumbent Board Members who were reelected. Ms. Kepler went on to discuss her concerns with the Board. These concerns included the recording of meetings, bullying in the school, the forfeiture of a basketball game in the winter, and the lack of supervision in her daughter's classroom. Ms. Kepler also stressed her support of the "Kickin' It" anti bullying program and indicated that she would like to see it institute in Bradley Beach.
