The workshop portion of the meeting held by the Bradley Beach Board of Education was called to order at 7:02 p.m. by President Franks at the school, 515 Brinley Avenue, Bradley Beach, NJ.

President Franks called for an Executive Session at 7:34 p.m. to discuss student matters.

Public Workshop Reconvened

On a motion made by Mr. Warnet, and seconded by Mrs. Carlucci, the Board reconvened into the workshop session at 7:45 p.m.

IV. Superintendent's Report

Dr Franks began the meeting by recognizing and thanking all the departing board members: Mr. Advento, Mr. Gerdes, Mr. Lozowick, and Dr. Monroe. Individual board members and administrators shared their appreciation, their history working with each departing board member and their well wishes to the four board members. Dr. Franks then turned the workshop session of the meeting over to Dr. Wisniewksi. Dr. Wisniewski gave the Board an update on the current status of the school reopening. Dr. Wisniewski informed the Board that Bradley Beach Elementary School is one of only 80 school districts that have been able to stay open from the start of the school year. This is both a testament of all the hard work of all the stakeholders as well as luck. Dr. Wisniewski stated that even with all the safety measures in place in the school, the district is still very lucky not to have experienced a need to move to a virtual learning environment. Dr. Wisniewski then gave the Board an overview of the impending snow storm and that the school will be having a virtual learning day on Thursday, December 17th, to ensure the safety of both the students and staff. The school will then reopen for a normal operating day on Friday, December 18th. Dr. Wisniewski then went over his agenda items, especially the submission of the New Jersey Quality Single Accountability Continuum (NJQSAC) District Performance Review, the approval of the New Jersey School Self-Assessment for Determining Grades under the Anti-Bullying Bill of Rights, and the resolution to participate in the Sustainable Jersey for Schools Corticate Program.

Dr. Franks then turned the meeting over to Mr. Tonzola. Before reviewing his agenda items, Mr. Tonzola gave the Board an update on the finance committee meeting that took place on December 8th and reminded the Board of the reorganization meeting on Wednesday, January 6th. Mr. Tonzola then reviewed his agenda items with the Board, in particular, the Special Education Medicaid Initiative Program waiver and the additional funds the district will be receiving with its new allocation of the CARES Emergency Relief Education Formula Grant.

On a unanimous voice vote the workshop portion of the meeting adjourned at 8:31 p.m.
